Major Contractor of the Year 2010

This award will be presented to a major contractor with turnover in excess of €20 million for the year 2009-2010, which has demonstrated a unique ability to win and complete high-profile projects within and outside its chosen sector(s) on budget and within deadline during tough market conditions. Applicants must also show an innovative approach to supply chain and human resource management, success in accessing new markets, as well as best practice in sustainability, health and safety and waste prevention onsite. Entries must be no more than 800 words in total and should include pictures to illustrate highlighted projects. Entrants must also complete the entry form overleaf.

Please provide this information on no more than four pages of A4. The entry form will not be counted in this limit. Please provide two copies of all entry material including the entry form.

JUDGING CRITERIA

In your submission please provide information on the following points:

- Summarise why your company deserves to win this award in 2010.
- Outline the projects and construction work that your company has been involved in the last 12 months and highlight any outstanding features, including any innovative solutions to difficult problems.
- What systems do you have for measuring customer satisfaction?
- What is your company's approach to sustainability?
- What is your company's approach to partnering with clients, contractors and suppliers?
- Have you introduced any new innovations in the last 12 months?
- What is your company's approach to health and safety policies? Highlight any achievements in this area over the last year.
- Explain your company's approach to training.
- Do you regard your company as a good employer – highlight any particular benefits you think appropriate.
- What strategic steps has your company taken to sustain or develop its existing business over the next 12 months?

Essential tips for a successful entry

- A successful application must address all of the points above to be considered.
- Where we have asked for specific information use headings to highlight your answers to specific questions.
- Concentrate on facts that can be substantiated.
- Include information on your exceptional successes during the year such as business innovations or techniques that have reaped significant benefits.
- You can use bullet points, charts and photographs in your submission. Photographs are particularly important for the judges to be able to see your projects or innovations.
- Additional information will not be forwarded to the judges unless specifically requested.
- Please provide us with two copies of all entry material including the entry form. If you are shortlisted we will need additional copies and we will contact you in this instance.
